### Drop/Add Project Deadline

Even though you needed to be enrolled by December 1 to be eligible to exhibit at the county fair; you have until May 1 to make changes in your projects. You can do this through 4HOnline or call the Extension Office and we can do it for you. If you are trying to do this in 4HOnline after May 1, you will not be able to make any changes.

Check over your enrolled projects NOW!! If changes are needed, make those ASAP. To exhibit at the fair in a project, **you must be enrolled in that project.**

### **YQCA** Certification

One of the requirements for those who plan to participate in the Kansas State Fair Grand Drive and/or KJLS is that ALL exhibitors are required to complete Youth for the Quality Care of Animals (YQCA) certification to be eligible for either show in 2024.

#### FOR ELK COUNTY 4-H/FFA MEMBERS:

Each 4-H/FFA member that wishes to sell animal(s) in the livestock premium sale at the county fair must complete YQCA certification training before **July 1**. Members may complete an online course or attend a face-to-face training. Once you complete a training, members will receive a certification number. That information will need to be forwarded to Stephanie Bogdahn.

#### Horse ID's

Horse project members need to turn in Horse ID's by June 1 on horses they want to show at the county

#### Families Needed for Hosting Japanese Delegates

More host families are needed for this exciting opportunity of hosting a Japanese delegate this summer. Eleven girls and six boys still need Kansas homes. The Japanese delegate will be in Kansas from July 21 – August 15, but host families are needed for July 23 – August 15. The 17 Japanese youth are between 12 – 16 years of age.

Any Kansas 4-H family with children aged 10-16, who are interested in the Japanese culture, may host. A separate bed is required, but not necessarily a separate room from the host sibling. Delegates are 100% medically covered with 4-H insurance and bring their own spending money for souvenirs. The delegates can go on host family vacations, camping trips, or join their host sibling for summer camps and the county fair. The focus is everyday family life.

If you have further questions, please call Pam Van Horn, Kansas 4-H Japanese Exchange Coordinator, 785-826-8917, or e-mail <u>pvanhorn@ksu.edu</u>. Also, this will be the third year that the Fechter Family has hosted a delegate.

**Benefits:** Increase your family's cross-cultural and global understanding, broaden family communication skills, make a new friend from another country, and have fun while leaning about Japan in your own home.

**How to apply:** Families may now apply on-line by visiting: <u>https://www.states4hexchange.org/apply/h</u> ost. There is a required application with references. In addition, there will be an in-home interview conducted as well as background checks conducted for all adults living in the household.

What you do: The host family treats the delegate as a family member (rather than a tourist/guest) and keep a "regular" family schedule. That could mean chores, fairs, camping, ballgames, etc.... very busy – or not so busy. It just depends on what your family likes to do! Most delegates will have studied English for one year in school. They are usually shy and don't want to make mistakes –so the first few days getting them to talk may be a challenge! The host family needs to be pro-active on ways to communicate without words, or using a Japanese/English translation dictionary, etc.

#### State Livestock Nominations

The 2024 information for state livestock nominations has been released. The process transitioned to an online system in 2022, so there are no longer physical forms for families to complete and mail. Families will purchase DNA envelopes in advance, submit their animal and exhibitor information online, then mail their completed and signed DNA samples by the deadline. Extension Agents and FFA Advisors will approve nominations online. Exhibitors who nominated animals last year (in 2023) need to use their existing ShoWorks account. Those who need help accessing their account may request a password reset through ShoWorks or contact the Youth Livestock Program for assistance. Returning exhibitors should not create a new account.

All market animals and commercial females that youth would like to be eligible for the Kansas State Fair Grand Drive and/or KJLS must be nominated. Market Beef nominations are due May 1, and Small Animals due by June 15. The deadline to order DNA envelopes is April 20 and June 5, respectively.

#### The Importance of Weighing Your Feed

You've probably heard it a time or two, but doing the simple things right is the fastest way to reach your goal. A lot of decisions go into what you are going to feed your show animals. So, when you dump that bucket of feed into the pan or trough morning and night, you want to make sure your animals are getting exactly the right amount. One of the best investments you can make for your barn or feed room is a simple fishing scale or postal scale. This allows you to weigh each bucket and measure out the correct amount of feed. The reason why we encourage people to stay away from the coffee can or feed scoop method is:

- 1. Your coffee can or feed scoop might not be the same size as your friends'. When you are consulting back with the breeder of your animal, and you tell him or her you are feeding a scoop of this or two scoops of that, that isn't giving an accurate picture of what you are feeding.
- 2. Different grains and supplements weigh different amounts even though the volume might be the same. For example, a scoop of oats vs. a scoop of corn vs. a scoop of cottonseed hulls will be very different weights.

Weighing your feed every day also keeps you consistent. It is easy for you to start to eyeball what you think 15 lbs. looks like, then realize you have only been feeding 13 or 14 lbs. once you weigh your bucket. By taking the extra step to weigh your feed, you'll ensure your show animals are on the right track for success.
